
1 The Ex Parte Application of Plaintiffs for an order requesting additional notice sent to the class,
2 extending the deadline to submit claims and continuing the final approval hearing came on for hearing
3 on October 11, 2022 at 8:30 a.m. in Department 15 of the above-captioned Court.

4 The Court, having reviewed Plaintiff's application and supporting papers, any
5 opposition thereto, and any argument made at the time of the hearing, finds that:

- 6 1. The claims administrator is to send additional notice to the Class Members, including:
 - 7 a. The sending of a reminder postcard notice to 1,488 class members (in a secure fold
8 over postcard);
 - 9 b. The sending of a reminder email to 769 class members;
 - 10 c. Skip tracing 2,290 records for cell phone numbers;
 - 11 d. Sending a text message notice to estimated 1,500 class members;
 - 12 e. The sending of a second reminder postcard notice 1 week later (in a secure fold over
13 postcard); and
 - 14 f. The sending of a second reminder email 1 week later.
- 15 2. The estimated notice and administrative costs in the amount of \$5,400.24 are approved and
16 shall be taken from the Settlement Fund.
- 17 3. The claims period will remain open until November 14, 2022.
- 18 4. The final approval hearing is continued until December 15 2022 at 1:30 ~~xxx~~m./p.m.
- 19 5. The Claims Administrator shall post notice of the changed date and a copy of this order on
20 the settlement website.
